Message

from the Executive Director



2023 has been a year of big challenges and immense pride!

We presented two musicals, most notably the mega-musical **CABARET**! This was a strategic decision to elevate the company's profile.

As a company that positions itself as a musical theatre specialist, it was crucial for us to present, for the first time, a top-quality, full Broadway-style musical. Until now, Sing'theatre had specialised in smaller musical revues and Off-Broadway type shows.

CABARET has surpassed our hopes. It has been incredibly well received by reviewers and the general audience, with many saying it was the "Best show watched in Singapore in 10 years" and "No need to go to Broadway anymore." Sing'theatre has made the industry proud of its local talents.

We are also very proud to have partnered with Mapletree Investments for the first time to create a brandnew musical for family, "**Once Upon a Like**," which was performed at VivoCity's 1,000-seat amphitheatre in November.

Our community outreach programs provided an average of more than one hour of live music per day to underserved communities. We impacted around 3,500 patients in public hospitals and around 8,000 people from the public. We presented 22 lobby concerts for patients at the main public hospitals, 115 concerts at patients' bedsides, and provided 118 singing classes to vulnerable communities.

We also resumed **Musicfest@SGH** after a three-year hiatus. More than 300 performers presented 70 performances, representing a total of 41.5 hours of music.

Our academy students made us very proud again this year, especially our adult ensemble, the Showstoppers, who presented the Broadway smash hit **RENT** in a sold-out run.

We concluded 2023 with **Singathon**, an annual fundraising event held during Giving Week, organised by the National Volunteer & Philanthropy Centre (NVPC). A total of 135 performers, all volunteering their time and talents, came together to deliver 12 hours of live music in front of an enthusiastic audience, as well as live streaming of the event on YouTube. Through these efforts, we managed to raise over \$63K from more than 480 generous donors!

None of this would have been possible without our incredible, passionate, and dedicated team, who worked tirelessly. I extend my heartfelt gratitude to each one of them, with a special mention for Syahindah, TJ, and Alice, whose positivity, energy, and talent have been instrumental in leading the company.

Additionally, we would not have achieved any of this without the support of the Cultural Matching Fund, as well as our private and corporate donors. I extend my deepest appreciation to each one of you.

I would also like to express my gratitude to our esteemed Board of Directors for their unwavering support and visionary guidance.




Jean Louis Michelet - Director

ORGANISATION STRUCTURE




Management & Staff




In addition to its full-time staff Sing'theatre employs interns during busy times and is assisted by volunteers as and when the need arises.



The expenditure has increased as we have produced a high-budget Broadway-sized musical called Cabaret.

The revenue earned in 2023 has been consistent with 2022.

Major Financial transactions

The lease on one of our studio spaces #02-03 Heritage Place was renewed effective 1st January 2024 at the monthly rent of \$6,600(not including GST) till 31st December 2026.

The company was also registered for GST with IRAS effective March 2023.

Purpose of charitable assets held:

All the assets of Sing'theatre are held to further its vision and mission of performing for a better society.

Principle funding sources:

Sing'theatre's community outreach programs and productions are funded by donations from the public, corporate donors and sponsors, grants from foundations and the government, most importantly the Cultural Matching Fund. Other sources of income are fees from the Academy and ticket sales from shows.



PRODUCTION

2023 Go big or go home!

I LOVE YOU, YOU'RE PERFECT, NOW CHANGE

In April we presented "I Love You, You're Perfect, Now Change!" at Alliance Francaise Theatre. It is the longest-running off-Broadway musical revue that tackles modern love in all its forms: from the perils and pitfalls of the first date to marriage, children, and the twilight years of life.

Told in a series of vignettes and songs, I Love You, You're Perfect, Now Change traces the overall arc of relationships throughout life. The show was set in Singapore to give a local touch! This insightful and hilarious musical had audience members shouting, "This is my life!"

The stellar cast included Andrew Marko (Falling, Mama White Snake, Rent), Benjamin Chow (Tartuffe, Urinetown, Rent.), Rebekah Sangeetha Dorai (Boeing, Boeing, Ghostwriter, Koko) and making her professional debut on the Musical Theatre scene was Misha Paule Tan. Misha was once a student of the Sing'theatre Academy!

We issued 2,173 tickets for the show with an occupancy rate of 66%.

CABARET

In October, we made our boldest move to date and presented **Cabaret** one of the most iconic and decadent musicals of all time at the Drama Centre theatre.

Featuring unforgettable songs like "Willkommen," "Cabaret," "Don't Tell Mama" and "Two Ladies," this exuberantly entertaining show transported you back in time to 1931 Berlin, where life was beautiful but dark forces were on the rise. Directed by Hossan Leong, the show had a stellar cast of 15, choreographed by the internationally acclaimed Lisa Keegan, and accompanied by an 8-piece live band playing infectious music directed by the award-winning Elaine Chan. The show boasted outrageous costumes (by award-winning Max Tan) and a lavish set (by award-winning Wong Chee Wai) that transported you to the seductive Kit Kat Club, where the flamboyant and sinister Emcee (Dwayne Lau) hosted nightly entertainment.

We issued 5,806 tickets and had an occupancy rate of 67.48%. While Cabaret was widely appreciated for its artistic value it was very expensive to produce and resulted in a great financial loss to the company.

ONCE UPON A LIKE

In collaboration with Mapletree Investments, Sing'theatre produced "Once Upon A Like" an exciting new musical based on the timeless Cinderella story made for the modern social media generation (and less tech-savvy family members, too!). Fun, current and full of modern references, this musical, made the whole family look at their social media with a different perspective through the medium of the beloved story of Cinderella that we all know and love.

Mr Edmund Cheng, Mapletree Chairman, said: "Sing'theatre first performed at our lunchtime performance series, Mapletree Arts in the City, in September 2022. With arts being one of the four key Corporate Social Responsibility pillars at Mapletree, we are pleased to bring them to VivoCity for a full-fledged one-hour inaugural performance. We look forward to presenting more artistic genres to the community moving forward."

"When Mapletree approached us with the opportunity to craft a musical performance at VivoCity, it became clear that we had discovered an ideal collaborator, united by our shared mission to make performing arts accessible to all," said Ms Nathalie Ribette, Executive Producer & Artistic Director of Sing'theatre.









SINGATHON 2023

ISingathon has become an annual event for Sing'theatre following the success of our previous ones in 2020, 2021 and 2022. On 3 December 2023, within the framework of Giving Week organised by NVPC, once again 229 performers, all voluntarily, came together to present 47 performances and 12 hours of live Music streamed on YouTube to raise funds for Sing'theatre. This time around we were able to have a live audience to watch and cheer the performers too due to the easing of safe distancing measures. We were able to raise approximately \$63K from over 480 donors!









COMMUNITY OUTREACH

365 Hours of Music

Our outreach program "365 Hours of Music" aims

- To bring quality music to hospitals, especially to those who do not have access to music because they are sick or are unable to afford tickets to a concert.
- To introduce patients, their families and caregivers to various genres of music and to open up new artistic horizons.
- To let the music, work its magic: to bring people together, to bond, to convey emotions, to rekindle memories, and to give energy and strength.

All in all, we had:

- 22 lobby concerts for patients at public Hospitals (from Jan to May 2022)
- 115 ward visits with both children and adults
- 118 singing classes with vulnerable communities

We reached approximately 3445 patients and 7383 general public members with our music.

MusicFest 2023

After a hiatus of 3 years due to COVID, the 10th edition of Musicfest was back on 26 May 2023 at Singapore General Hospital.

MusicFest@SGH was conceived with the belief that music has **the ability to stimulate the senses**, **heal**, **uplift the spirit**, **and improve a patient's journey to recovery**. With this outcome in mind, Sing'theatre and SGH presented the first MusicFest@SGH in 2013.

After 9 successful editions, Musicfest was back in 2023 with 302 performers both professional and amateur, 130 volunteers, 70 performances, 41.5 hours of music at 7 locations around the SGH campus between 10:30am and 5:30pm. The day of music culminated in an evening concert enjoyed by the staff, patients, volunteers, and visitors.

ACADEMY

In 2023, our Academy enrolment stood at 74% compared to 86% in 2022. We had 25 classes with 228 students as compared to 240 students in 2022.

Our open mics which are extremely popular with the musical theatre community flourished. We held 7 open mics in 2023 compared to 3 in 2022. Over 700 people joined us for the open mic nights in 2023.

Sing'theatre Academy's performances in May and June 2024 were a remarkable success, showcasing the incredible talent of our students through a series of vibrant and captivating productions. Here's the list of shows that were performed by our talented students:

Show Line-up:

- 1. Munchkin Mayhem for Rising Stars
- 2.Oz for WES, BWS and Showstoppers
- 3. Follow the Yellow Brick for Super Stars
- 4. RENT for Showstoppers
- 5. Broadway Blitz for Stage Doors

Given the limitation of 30 seats per performance and tickets sold exclusively to parents, each show reached full capacity, ensuring a personal and engaging experience for the families involved.



RENT

In June/July, the crème de la crème of Sing'theatre Academy, the "Showstoppers" presented the beloved musical "RENT"

Rent is a musical theatre favourite, with most millennial Broadway geeks growing up with its classic songs such as "Out Tonight", "Take Me Or Leave Me" and of course the anthem "Seasons of Love." Rent covers some hard-hitting issues facing New York at the height of the AIDS crisis, but at its heart is a story of overcoming odds and the enduring power of love.

We continued our mission of performing for a better society by developing the next generation of performers at Sing'theatre Academy with the Showstoppers Musical Theatre Ensemble.

Rent was presented at SOTA with 1,000 tickets issued at 100% occupancy.







THE YEAR AHEAD

Community Outreach

In 2024, we will continue our mission in hospitals. We are bringing back "Sing Me A Story" to KK Hospital our community outreach program that brings superheroes and fairy tale characters to the lobbies & wards of the paediatric wards in the hospital.

Production

We will have to cut back on production as we had a bad year financially in 2023. We will present "Little Shop of Horrors" in April 2024 at SOTA as our only big production for 2024.

<u>Academy</u>

In 2024, we will continue our academy classes with Children & Adults. We will open our first mini stars classes for children aged 3 to 4 years old. The children will be putting on Aladdin the Musical. Our teenage Broadway stars and Adult Showstoppers will be producing Grease the Musical.

Fund Raising

Our annual fund-raising concert Singathon will be held as usual in December 2024 to raise funds for our community outreach activities.

We hope to raise approximately \$528K in 2024. This is an extremely optimistic target, but we need it to help to motivate us and build back our reserves.

Expenditure

Estimated expenditures are as follows:

- Fund raising \$50K.
- Charitable activities \$820K
- Administrative costs \$1,080K

GOVERNANCE
